### **Omaha Metro Medical Response**

During the January AARC meeting a talk was presented by Dr. Tom Williams, who co-chairs the Omaha Metropolitan medical Response System (OMMRS) Communication Subcommittee. The OMMRS was created after 911 to help metro area hospitals plan coordinated esponses to natural disasters and the use of weapons of mass destruction by terrorists.



OMMRS Communications Subcommittee

OMMRS is composed of volunteers from the Dr. Tom Williams - WXØL details the public, private and government sectors and in-

cludes the Douglas County Department of Health, Offutt AFB, Douglas County Sheriff, Public Works, FEMA, area hospitals, Nebraska State Patrol, Nebraska Emergency Mgmt, FBI, Nebraska Humane Society, Henry Doorly Zoo, Douglas County EMA and Douglas County ARES, to name a few.

One of the main issues being addressed by the Communications Subcommittee is how to provide communications to the medical infrastructure in the Omaha area following a disaster. One thing everyone agrees upon is that in a disaster the public communications infrastructure would either collapse under heavy public demand or, at a minimum, suffer along at a severely degraded level. So the obvious question is "What communications alternatives remain?"



While the answer seems obvious to us Amateur Radio operators, great care was taken to ensure that the system chosen was flexible, robust, economical, simple and able to work across jurisdictions. Time and again the system that jumped to the top of the list was Amateur Radio! An added plus is that Amateur Radio already has a large infrastructure in place with a solid core of volunteers familiar with radio communications technologies.



So with Amateur Radio being the chosen method of ensuring continued communications during disasters the job of determining who, what, where, when and how was begun. A plan to link hospitals, EMA/EOC, public health, the media, poison control, vaccination sites, alternative care centers, and personnel processing points was developed. Already tri-band amateur radio antennas and coax has been installed at area hospitals. Also, 2-meter, 220 Mhz, and 440 Mhz radios have been purchased for these same hospitals and are currently awaiting programming down at the Douglas County EOC.

to man the equipment in the event of a disaster. Volunteers will have to be trained not only in communication techniques but also hospital policies and standards of conduct as well as training to understand the various types of chemical, nuclear and biological agents that these facilities may be treating. The last thing the hospitals want is for their volunteers to become causalities, and in the case of weapons of mass destruction fore warned is definitely forearmed.

Now the hard part – getting and training enough Ham volunteers

While area ARES groups have stepped up to the plate, many more volunteers are needed. ARES officials are working with area hospitals to design campaigns to solicit individuals willing to take up amateur radio as a means of supporting Homeland Security. The campaigns will target not only hospital employees put also patriotic citizens visiting hospitals. But remember that hospitals aren't the only areas that Hams would be asked to staff. The Red Cross, Douglas County EOC, The Douglas County 911 center, incident sites, area shelters, Offutt Airbase and other sites will require our services. Of course Murphy's Law would force us to consider that all this could also happen during severe weather season.

So as you can see, your community needs you – the licensed Amateur Radio operator as never before. Now is the time to get involved, or reinvolved, in your local ARES organization. Contact your County Emergency Coordinator and ask how you can help. Don't wait for a disaster to occur before you get involved. Advanced training and education now can help save lives later – possibly even your own.

## The Psychology of Jamming

This article, a reprint from an earlier issue of the Ham Hum, is an excerpt from an article from Radioworld and was written by Joe Morell, WA6JFP.

A different approach to the problem of deliberate interference was taken by the Fullerton (CA) Radio Club when "The Psychology of Jamming" was presented at a recent meeting. Dr. Roberta Trieschmann, a clinical psychologist, told the group about the motives of those who maliciously cause QRM and the best ways to get them to stop. Dr. Trieschmann started out by commenting that interference problems in Amateur Radio seem to parallel our entire society's "me first" attitudes where etiquette and consideration for others is on the wane. Also the anonymity of being a jammer provides a convenient way to the sense of powe rlessness they may feel about other areas of their lives.

She had the following suggestions for counteracting jamming.

1) DON'T RESPOND! Even if only one person responds in some way, reinforcement and encouragement are provided to the jammer. Remember, what he/she wants is attention. You won't hear jamming on unbusy repeaters. No audience, no jamming.

- 2) REDUCE ANONYMITY. Unless he/she has a specific vendetta, jammers usually don't jam people they know. Your repeater club or other local ham group should reach out to encompass all users and active hams. Who knows, you may turn a jammer into a productive ARES member!
- 3) SUPPORT THE FCC. Letter writing at the national level may help the FCC to get the funding they need to combat interference successfully.
- 4) SET AN EXAMPLE. Put articles in your club newsletter on proper procedure and common courtesy. Make sure your own operating procedure is beyond reproach.

Although not an amateur herself, Dr. Trieschmann received a thorough introduction to our hobby before her presentation, including hearing many examples of jamming on both HF and VHF. Many persons in the twice-normal crowd attending the meeting commented the fresh views of a non-ham were quite useful.


