PUBLIC WORKS ASSISTANCE

The Public Works Department of Omaha has requested that local amateurs help provide road condition information throughout the coming winter season. During snowfall or icy periods such information will be used to aid the dispatching of trucks with salt, sand or plows.

KØUDK, Jack, will be the prime contact with Public Works and will be asking for such road condition information via the Omaha Repeater (34/94). During periods of light or moderate snowfall, it is planned to gather such information in an informal manner without putting the repeater into a controlled net operation. Should snowfall become heavy or develop into a blizzard, operations could easily be shifted into formal net procedure.

During periods of snowfall, the cooperation and reports of all repeater users (particularly mobiles) will be



TULSA AREA AMATEURS PREPARE TO DEFEND THEIR RIGHTS

On 17 September 1975 a group of approximately 50 Tulsa area amateurs met to show strength at the hearing on the TMAPC Board of Adjustment. The action was taken by the neighbors of Jim Pickett, K5LAD, to appeal the City of Tulsa's issuance of a building permit for Jim's 69-foot Rohn 45 foldover tower.

In a marathon 2-hour deliberation on this one case, the appeal was upheld by the Board. This meant that Jim's building permit was invalid. The Board did agree that Amateur Radio is incidental to a residential area and thus would be permitted in the amateur's home. They also agreed that, according to existing ordinances, there would be no height limitation on an antenna (aerial) but that a supporting structure for an antenna could not exceed 26 feet.

At this point any tower higher than 26 feet is in violation. No future towers may be erected which will exceed the 26-foot limit. Any deviation from this decision will have to be individually decided by a variance.

Jim has a choice of several options. Because his tower was erected in compliance with a legal building permit and the tower was up before the Board's decision, he could apply for and doubtless receive a variance on his own case. If this were done, Jim would be okay, but it would leave all Page 8

other Tulsa amateurs stuck with a 26-foot restriction. He has chosen to appeal the case to District Court to clear up the point for everyone. The appeal will run in the neighboorhood of \$1,000.

This is not K5LAD's fight alone by any means. This is the fight of every amateur in Tulsa, to be sure, and all interested amateurs around the country. The Executive Board of the TRO met and has decided to head up the fight. Max Attebery, WB5BET, and Don Johnson, W5PYA, have agreed to handle the trust fund for the Legal Defense. This fight must not be allowed to lose; the cost must be shared by everyone because it is everyone's fight. The ARRL providing some help in the legal line but the finances must come from us.

Donations are appreciated in whatever amount you can afford. Everything from \$5 to \$20 has come in so far from individuals but amounts less or more would be appreciated, and welcomed. Jim will appreciate your help and you will be helping yourself and Amateur Radio in Tulsa for years to come.

COUNCIL REJECTS PLAN TO REGULATE ANTENNAS

im CHULA VISTA, CA - The City all Council decided against requiring HAM HUM December 1975 conditional use permits to regulate the installation of antennas by Amateur Radio operators and citizens band radio groups.

After a 90-minute hearing and cussion last night (7 October 1975) the council felt it did not want to adopt an ordinance because the problem does not appear to be widespread.

The subject was introduced after a complaint was received about a year ago about an unsightly Amateur Radio antenna on Corte Maria Avenue.

The councilmen considered requiring conditional use permits for three-dimensional antennas that resemble box kites.

Amateur radio operator Leonard Babin, WA6CQF, said such a restriction could not be aimed at amateur and citizens band radio operators only, but would have to include all antenna — private, commercial, government and television.

It was discovered that several home television antennas could fall into this category and some governmental facilities, including the city's fire communications antenna, could be affected.

The council chambers were packed with radio operators who explained that they were working on a solution to the Corte Maria problem which some members of the City Council called "a backyard dispute."

Hi:

There must be many 6 volt, full wave battery chargers lying idle. So, why not use a bridge rectifier, get 12 volts at ½ the amperage? From the bargain pages — 4 12 Amp. 100 PIV, Silicons. One 1 ohm 12 watt Brown Devil resistor.

Connected the bridge, silicon rectifier, to the outside wires of the transformer, connected to battery—gave 7 amps—ran stinking hot. Connected the 1 ohm Brown Devil in series, charged at 4 amps. Ran cool. Unloaded volts 14 v.

So why not use it for a 4 amp. power supply for the 2 meter rice-box? Paralleled a 3000 MFD cap. with a 400 ohm bleeder resistor, across the 12 v. output, plug in the rice-box - pilot lite very brite - but on the air test, no hum or ripple. Checked voltage - unloaded, 21 v. on receive, 18 v. on transmit 16 v. Unplug and ORT that test. (Double check with a cheapie 12 volt power supply for direct use on rice-box, that showed, unloaded 15 v. on receive 14 v. on transmit 11 v.) Conclusion . . . a 6 v. full wave battery charger, @ 8 amps, may be converted to a 12 v. bridge rectifier, with a 1 ohm 12 watt dropping resistor and make a good battery charger, but until someone does more work on the project, do not use it on a 2 meter rice-box, direct.

The chart reflects the major changes that have been made among frequency allocations since 1969. This chart will inform the viewer to what activity and to what service a given frequency band is assigned.
