#### Official Record Minutes of the Board of Trustees Meeting Ak-Sar-Ben Amateur Radio Club, Inc. - January 2004

The Ak-Sar-Ben ARC Board of Trustees met on January 6, 2004 at the Red Cross Emergency Services building at 80th Avenue and Spring Streets in Omaha, Nebraska. President Steve Schmitz, NOUP, called the meeting to order at 7:00 p.m.

AARC Officers and Board Members Present: President Steve Schmitz, NOUP; Vice President Kurt Kettelson, KCOHMI; Secretary Ken Noel, AJ0A; Treasurer Mary Joseph, N0TRK; and Board Members Sam Bellami, KCONWL; Kevin Hill, KA0VNY; Bill McCollom, KE0XQ; and Geri Norris, N5RIG.

Editor's Note: Two open board positions resulted from the election of N0UP to President and KC0HMI to Vice President at Annual Business Meeting last month. A slate of nominees will be presented and voted on tonight, then presented to the general membership on January 9, 2004 for approval.

Visitors Present: Bill Newman, K0NSA; Linda Newman, W0NSA; Steven Wisnieski, KC0LOD; Marvin Taylor, AE0EG; Dick Jones, N6KVA; and Pat Joseph, K0CTU.

<u>**President's Report:</u>** "We have stuff to do!" Steve NOUP handed out the agenda for tonight's meeting.</u>

<u>Vice President's Report:</u> Kurt KC0HMI is working to line up programs for this year. Ideas and suggestions are welcome. There is a poll on the Club's web site that contains a list of ideas for possible programs. The program for the January Club meeting will be presented by Mark Conner, N9XTN, on NSTAR (Nebraska Stratospheric Amateur Radio).

<u>Secretary's Report:</u> The December 2003 Board minutes were presented to the Board. No additions or corrections were noted. Geri N5RIG moved to accept and Mary N0TRK seconded. No discussion. Motion carried.

<u>**Treasurer's Report**</u>: The December 2003 Treasurer's report was presented to the Board. The following balances were reported:

Total Assets of \$29,366.75 comprised of the checking account \$952.39 (includes \$39.00 in repeater donations that will be transferred to the repeater account); repeater account \$100.26; savings account \$4,588.49; life membership CD \$13,827.97; and club property \$9,897.64.

Total Liabilities of \$20.00 comprised of two free memberships.

Total Liabilities & Equity of \$29,366.75.

Income and Expenses of 1,083.16 and 331.96 respectively for a net income of 751.20.

#### **Standing Committee Reports**

**Disaster Preparedness:** Bill KONSA gave a brief overview on the CERT (Community Emergency Response Team) program and an upcoming training opportunity in February 2004. A short Power Point presentation will be made at the January Club meeting during committee re-

ports. Ken AJ0A, also requested that other training opportunities like Red Cross Introduction to Disaster Services and Damage Assessment is included in the committee report.

<u>Education</u>: Committee chair is open. Kevin KA0VNY volunteered.

**Public Relations:** Linda W0NSA commented on the Younkers event as a way to generate PR and income but volunteers are needed. Younkers require the participating organization to be non-profit under IRS 501c3 which the Club is.

**Repeaters:** Steve NOUP noted that KETV has offered space on their new tower to the Club. It's anticipated the KOUSA 34/94 repeater could move to the site in July or August of this year, but the move will be costly; on the order of \$1,700 for the antenna mount and other hardware. The Club has a commercial grade antenna and some 25-year-old 7/8" hard line. The antenna should be OK but new hard line should be installed if funding or donations are available.

Publications: Open position.

Government Relations: Open position.

Technical: No report.

**Membership:** Mary N0TRK is planning to prepare and send reminder notices to members that have not renewed for 2004 and also to past members inviting them back to the Club. Also looking into other venues like the Cox Community Calendar to announce Club meetings. Ham Hum is available at the Club's web site. This is the preferred and less costly method for delivering the Ham Hum. Should the membership application be changed to include a check box for the option of having the Ham Hum mailed to the member or leave it off altogether? Web site may have a member's only area. Steve NOUP noted that it costs approximately \$12 per member per year to print and mail the Ham Hum, and dues are now only \$10.

**Field Day:** Steve N0UP stated there will be a Field Day this year. Lots of volunteers are needed.

<u>Other Committees:</u> HF Contest & DX committee being chaired by Todd LeMense KK0DX. Thanks Todd.

#### END OF COMMITTEE REPORTS

Appointment of Board Members: Steve NOUP presented five nominees to be voted on by the Board to fill two vacant Board positions for the remainder of the year; they were: Dick Jones N6KVA (present), Todd LeMense KK0DX (not present), Marvin Taylor AE0EG (present), Barb Westcott KC0HLB (not present) and Steven Wisnieski KC0LOD (present). Nominees present were invited to speak on their behalf and to accept or decline the nomination. All accepted. Nominees and other non-Board members were asked to leave while paper ballots were cast and counted. All nominees received votes. Marvin AE0EG and Steven KC0LOD were appointed and will be presented to the General Membership on January 9, 2004 for approval.

**Old Club Business:** Steve NOUP addressed Life Membership issues. With the reduction in regular membership dues from \$20 to \$10, the Board at their December 2003 meeting acted to place a moratorium on <u>new</u> life members until the financial issues could be adequately addressed. Interest on the Life Membership fund was intended to cover a Life Member's dues for the life of that member. However, in today's current interest rate environment and with 78 life members, this amounts to only \$3.25 per life member.

Two options will be considered. Formally amend the bylaws to address life membership issues, or lift the moratorium and leave the by-laws unchanged. Discussion on increasing the life membership rate to the greater of \$500 or ten times current dues, assessment on existing life members, and no longer accepting new life members but recognize all existing life members.

Motion was made by Kevin KA0VNY to amend Sections 6 and 9 of the Club's by-laws to read as follows (the old is stricken through; new is underlined). Sam KC0NWL seconded. Kevin KA0VNY amended his motion regarding Section 9 to change wording from "...no new life memberships <u>will</u>" to "<u>shall</u>." Sam KC0NWL seconded. Motion carried.

Section 6.

(Amended 6-7-94, 3-5-96, 12-3-96, 12-1-98, <u>1-6-04</u>) **< snip >** 

-Life, Honorary Life, and Charter Life and Spouse Life. A life member shall have the privileges of a regular member and shall receive a club nametag. The spouse of a member elected to Honorary Lifetime Membership shall be eligible, upon request, for all privileges of spouse membership and shall not be required to pay dues to the association.,

-Spouse. A spouse member shall have the privileges of a regular member except that said spouse member shall receive the club newsletter only for notification of the annual business meeting. A spouse member may become a Life member at twenty five (25) times the Spouse rate if his or her spouse is already a Life member or is simultaneously applying for Life membership. Upon the death of a Life member, the surviving spouse, may request transfer of the Life Membership to them. Upon the transfer, the surviving spouse will be considered a 'Life Member' with full privileges.

Section 9.

AK-SAR-BEN Amateur Radio Club, Inc., members in good standing for the past five or more consecutive calendar years are eligible for lifetime membership by paying (25) Twenty-five times the current regular yearly membership rate. This amount is to be deposited in an interest bearing lifetime membership account. This account shall be established to provide for payment for the lifetime members' annual dues from the accrued interest. Deposits shall remain in the account for a minimum of one year. The AK-SAR-BEN Amateur Radio Club recognizes the existing life members, no new life memberships shall be granted. In order to compensate the General Fund for surviving members' annual dues interest earned by the life membership fund during this period may be withdrawn at the end of the fourth quarter to compensate the General Fund for surviving members' annual dues, but the amount of the withdrawal shall not be greater than the annual dues. Unused interest shall be added to the principal amount. The principal may only be withdrawn after the lifetime member becomes deceased. At that time, the Board of Trustees shall have the

authority to withdraw the principal amount and any remaining interest on behalf of the deceased lifetime member, and utilize those funds in the interest of the general membership. While nothing shall prevent the membership or Board of Trustees from carrying out their rights and responsibilities granted them by the Articles, the Trustees are encouraged to give careful consideration to disbursement of these funds.

#### END OF OLD BUSINESS

#### **New Club Business**

Red Cross Memorandum of Understanding (MOU) and Conference Center Usage Policy: Received by Steve NOUP. Room usage fees are now required for organizations that use Red Cross facilities. However, the fee is "waived for the Ak-Sar-Ben Amateur Radio Club." Instead a credit card number that could be charged in the event that damages are incurred or special cleaning is required. The Board generally agreed that providing an individuals credit card number would not be acceptable. Ken AJOA agreed to approach Red Cross officials with the following alternatives: the Club might be able to obtain a secured credit card; Club liability insurance; cash deposit.

Editors note: The Red Cross agreed to a nominal \$100 deposit!

The MOU also indicated that a CheckList would be left behind for the organization to use when returning the room to its original set-up. The Board noted that no list was found in the room.

#### Official Record Minutes of the Business Meeting Ak-Sar-Ben Amateur Radio Club, Inc. – January 2004

The Ak-Sar-Ben ARC met on January 9, 2004 at the Red Cross Emergency Services building at 80<sup>th</sup> Avenue and Spring Streets in Omaha, Nebraska. President Steve Schmitz, NOUP, called the meeting to order at 7:30 p.m. with the Pledge of Allegiance and the standard announcements. There were 56 members and visitors present.

**President's Report:** Red Cross Memorandum of Understanding (MOU) and Conference Center Usage Policy. Room usage fees are now required for organizations that use Red Cross facilities. However, the fee is "waived for the Ak-Sar-Ben Amateur Radio Club." Instead the Red Cross will accept a nominal cash deposit of \$100.

The position of Door Prize "procurer" is open. Steve N0UP asked for a show of hands for those in favor of continuing with monthly door prizes. Only six people raised their hands in favor.

The position of donut/refreshment "procurer" is open. It does not take a lot of time. If refreshments are wanted at the meeting, please volunteer.

Editor's note: No cookies or donuts were available tonight; only coffee.

The position of Publication's Chairman/Ham Head editor is open. If you have a trace or printer's ink in your blood, Steve would like to hear from you.

Steven KC0LOD and Marvin AE0EG were appointed by the Board at the January Board meeting. Bill K9RZ moved to accept the new appointees. Mitch KC0MXV seconded. Motion carried.

Sections 6 and 9 of the Club's by-laws that address life membership were amended at the January Board meeting. Steve NOUP read the Sections 6 and 9 noting the changes. John WB0CMC moved to affirm the Board's decision. Mike KA0SFV seconded. Hand vote: 41 for; 0 against.

A review of the Club's by-laws needs to be undertaken. Steve N0UP will sit on a committee but will not chair. See Steve is you can help.

**Treasurer's Report:** The December 2003 Treasurers report was prepared by Mary N0TRK and read by Ken AJ0A. The following balances were reported: checking account \$952.39 (includes \$39.00 in repeater donations that will be transferred to the repeater account); repeater account \$100.26; savings account \$4,588.49; life membership CD \$13,827.97; and club property \$9,897.64. Total assets of \$29,366.75. Total Liabilities of \$20.00 were comprised of two free memberships. Equity of \$29,346.75. Income and Expenses of \$1,083.16 and \$331.96 respectively for a net income of \$751.20.

Question was raised about how much in donations the Club has received as a result of its non-profit (IRS 501c3 status). Information on hard and soft (or in kind) dollar donations was not available as the books were just closed for the month of December 2003, and the annual report was not ready. Hard dollar donations are basically cash, like the UP donation last year and the Younkers sale events (Younkers require participating organizations to be 501c3). Soft dollar or "in kind" donations are like tower space for repeaters, hardware, etc. which can run into the hundreds if not thousands of dollars.

Editor's note: a recent example would be KPTM. KETV will probably be another.

<u>Government Relations:</u> Jeff, NEØDX noted there may be another stab at addressing tower ordinance issues in Omaha.

**Repeater:** John WB0CMC reported that Club owned repeaters are all working. Planning is underway for the move of K0USA 34/94 repeater to KETV's new tower this Summer. KETV is graciously donating tower space at approximately the 650' level and should be able to cover the cost of a professional tower crew since they should already be on-site. The tower will have an elevator. Access to the site will addressed. The Club will need to pay for the hardware costs; at a minimum \$1,700 for specially constructed antenna to tower mounts and other hardware. The Club has a commercial grade antenna and some 25-
