



Now that the summer doldrums are past and winter is fast approaching, it's time to put another log on the fire, grab your favorite refreshment, tune the rig and enjoy another season of DXing.

Again, contests are a good way to help fill your DX larder. One of the biggie DX contests has gone by (CQWW) and although a flare came near ruining the bands on Friday, Saturday saw an improvement and by

Sunday, the high bands were really cooking.

The ARRL ten-meter contest is upcoming (11-12 Dec.) and in March the second biggie contest, ARRL WWDX. Don't overlook some of the smaller, localized contests sponsored by the individual countries. QST,

73 and I'm sure other magazines will give all the dates.

A number of DXpeditions are planned, with the VKØ-Heard Island expedition having the greatest interest to DXers. Planned departure for "Heard" tentatively set for early January 83, with stops (and operating) at FB8Z-Amsterdam and FB8X-Kerguelen. I've heard about the possibility of DXpedition to FOØ-Clipperton in early "83" but nothing definite, check your DX bulletins.

1982 ANNUAL MEETING AK-SAR-BEN AMATEUR RADIO CLUB, INC.

In last month's issue you were informed that the Annual Meeting of the Corporation will be held at the Heartland Chapter, American Red Cross, December 10, 1982 at 7:30 p.m. We are repeating the

nominees selected by the Nominating Committee.

The Club Articles of Incorporation provide for the election of a President, Vice President and four members of the Executive Council each year. The President is elected for a one-year term, with an additional term as Immediate Past President, two years total. The Vice President is elected for a one-year term. Four members are elected each year to the Executive Council with a two-year term; thus, we elect 6 members and have 5 remaining on the board. The nominees selected by the Nominating Committee are presented at the Annual Meeting. Additional nominations will be requested from the floor and may be made by any member at the appropriate time.

The procedure will be as follows:

First, the nominations and voting for a President.

When the ballots are counted and the President is elected, we proceed to

Second, the nominations and voting for a Vice President.

When the ballots are counted and Vice President is elected, we proceed to



Dear Sir,

In response to your request for assistance in eliminating your RFI problem, an investigation of your station installation and operation was made on October 17,1982.

The complaint, filed with the base frequency manager, by your neighbor Mr. Mann, stated that your amateur radio station caused interference to their 'auto-dial-type' telephone set. Discrepancy reports by the telephone company serviceman showed that this type of telephone has a history of susceptibility to RF interference, and is therefore unable to receive FCC type-acceptance at this time. In short, the design of this type of telephone leaves it vulnerable to outside signals, consequently, the interfering signal is blamed when in fact the problem is one inherent in the telephone set design.

Our findings were conveyed to TSgt. Phillips and his staff in a phone conversation, and with which they concurred, that this problem is the fault of the telephone set and should not cause you to be deniedto maintain and operate your FCC licensed Amateur Radio Station. The results of this investigation have shown beyond a reasonable doubt, that the radio equipment in question is clean of unwanted and/or spurious emissions, and that the installation of this equipment has been made in compliance of good electronics practices.

It is my understanding that this matter has now been resolved and should not pose any additional problems to you. Should our assistance be necessary in the future, please do not hesitate to contact us.

Applicants for field exams will be notified of the place, date, and time of the examination, approximately one week before the exam date. Examinations are by **APPOINTMENT ONLY.** Persons without an appointment will not be admitted.


