# Minutes of the Board

The October meeting of the Board of Trustees was called to order by Club President Jim Sanford NOAIH at 7:16pm, October 7, 1986 at the Red Cross Chapter House. Board members present were: Jim Sanford NOAIH, Jim Nichols KB8TR, Jim Faulkenberry N5DZZ, Doug Halbert KOBOY, Ken Walker KDOP, Bill True WA9ASD, Greg Zimmerman NOBTN, Scott Persson WBOQPP and Jim Peterson WBOQGV. Mitch Gagne NOAZF was an attending guest.

Committee guides were distributed by the committee chairmen. Jim NOAIH indicated that he plans to make a book from all of the guides. Each year, every committee chairman will receive a copy of the book to help as a guide to running the committee.

## Repeater Committee Report - Jay KB8TR

The "cutout" problem on the 146.34/.94 repeater has been solved. The problem was caused by characteristics of the human voice. The repeater has a mute function that silences transmitted audio when a touch-tone is received. So, when someone's voice harmonics happened to hit a touch-tone, the receiver muted, producing the "cutout" effect. The mute function has been adjusted to correct this problem.

Jim NOAIH reported that Kevin Ferris, an employee of ATS, has offered the Club a complete 432 MHz repeater station as a donation. Features include a four-receiver voting system with satellite receivers throughout our area and the repeater site itself is included. The system would give hand-held coverage to our entire area. A 432 MHz repeater frequency has been coordinated through Joe Eisenberg WAOWRI. Discussion revealed that the Board felt that the Club could not pass the offer by.

Jim also reported that 27 high-power transmitters have been removed from the Woodmen Tower's roof and that the Club still has Grandfather rights to the roof. Discussion was centered on moving the Club's 220 MHz repeater from the Channel 6 tower to the Woodmen Tower. Jay KB8TR will discuss the situation with John Gebuhr WB0CMC.

### Equipment Committee Report - Jim NOAIH

Jim NOAIH reported that the County turned down the Club's request for storage space at the county garage. Walt Brown KAODMB has a resolution before the Omaha City Council to allocate the Club space at one of the park maintenance facilities. The outcome should be known in a week.

A motion was made and seconded to pay the bills totaling \$275.92. The motion passed.

### Publications Committee Report - NOAZF

Mitch NOAZF reported that he will not be leaving Omaha with Enron as he previously thought. Therefore, he will continue to perform the duties of the Publications Committee Chairman for HAM HUM. The computer system currently being used for HAM HUM is barely adequate and is terribly difficult to use. Mitch proposed that the Board consider an investment in a computer system more oriented toward desktop publishing. An IBM-Compatible computer with a hard disk drive, one floppy drive and a 9-inch dot-matrix printer (for draft copies) would be an ideal system. The letter quality printer currently being used would still be used for the final print. Considerable discussion of computer systems and software ensued. The Board decided to form an ad-hoc committee consisting of Mitch NOAZF, Jim WBOQGV and Scott WBOQPP to investigate and recommend a system for the November Board meeting.

### New Business

Jim WB0QGV reported that a state tax law will go into effect that may change the way the Club handles the annual Auction. Jim handed out copies of the legislative changes and the Board recommended that the document be clarified through a letter to the State Attorney General's Office.

Jim also gave the Board details on an October 25th Ham Radio demonstration to the Boy Scout Leaders at the UNO Student Union from 8:00am to 4:00pm. Volunteers are requested to help.

Greg NOBTN moved that the Club give \$50 to AMSAT for a Club membership in the organization. The motion was seconded by Jim WBOQGV and passed unanimously.

Bill WA9ASD reported that General license classes will begin next week and that he needs instructors. The Board recommended that Bill postpone the classes until an instructor schedule can be drawn up and gave him a list of potential instructors.

Greg NOBTN told the Board about an idea to organize a non-credit course on Ham Radio at Metro Tech. The idea was met with great enthusiasm and Greg will persue the possibility with Metro Tech officials.

The meeting was adjourned at 9:50pm.

# On Line.

### By Scott Persson WBOQPP (SYSOP)

Last month I straightened out a few errors by presenting details on the operation of our system. I hope the numbers were interesting. During the last few weeks, quite a few new users have joined us and there are several common questions being asked. In addition to that, some of our "regulars" are finding certain things a bit confusing.

### You Want To Do What?

"What are the log-on parameters for my terminal?" Use 300 baud, 8 data bits, 1 stop bit and no parity. If, when you make connection with the system, the system tells you to "Press RETURN" over and over, your parity is probably set to "odd" or "even". This is a common mistake and can cause frustration because you've probably said "I AM pressing RETURN you !@#\$%^&\* computer!" more than once!

"How do I read a message?" Well, you can't, so there. No, just kidding! There are two "Menus" on the system, the Main Menu and the Message Menu. After you successfully log on, you are in the Main Menu. To read, enter, delete or scan the message base, you must "switch" to the Message Menu. This is done by selecting "M" from the Main Menu. NOW you can select "?" and the Message Menu will be displayed for you, listing the options available for messages. To get back to the Main Menu, select "M" again.

Also, there are two methods of reading messages: one at a time, or in a group. To read a message, select "R". The system will then respond something like "23 Messages Numbered 34-88" and then "Number (From-To):". At this point, typing in a number like "34" will let you read message 34 only. After the message is displayed on your screen, you will be back at the Message Menu prompt. To read a group of messages, enter "34-88". This tells the system that you want to read all messages from 34 to 88 inclusive. The system will also pause between each message and ask you if you want to continue to read the next message. That gives you time to browse through each one without having it scroll off of your screen.

"What is a SYSTEM ERROR?" A SYSTEM ERROR means you broke my computer and now owe me more money than you could possibly imagine. Go ahead, try to imagine a lot of money. Well, you owe me twice that! No, really, a SYSTEM ERROR means that an error occurred that the system could not recover from in any way other than to tell you that one occurred. An example of one such error would be a disk I/O error. Diskettes experience heavy use on BBS systems and frequently go bad in many ways. If the system tries to read a file from a diskette that went bad, you get a SYSTEM ERROR. This is only one way that a SYSTEM ERROR could occur. Just make the check payable to me.

"Why is upload space so limited?" There are now two drives on the system so the space problem should be lessened for a while. There is now 88k available for uploading and another 88K available for download files.

"Exactly what computer are you using?" All of the computer equipment used for the system is owned by me. An Atari 800 is running the system with two 810 disk drives (88K each), a 1030 direct connect modem and 825 printer. Another Atari 800 is responsible for maintaining the various system text files like the bulletins and news files. A third 800 is being used for off-line program maintenance and development.

"When are the line-feeds going to work?" THEY WORK NOW! Yes, I have solved the infamous line-feed problem that baffled and bewildered us for so long. "So what?" you mutter? Well, now you can have the system send you line feeds! Now everything won't be printed on the same line! Now all the bugs are fixed! But other than that....

"What fascinating topics are you going to amaze us with next month oh all-knowing sage?" Ok, ok, no one really asked that question in those exact words. Ok, no one really asked that question at all. Happy?

### You Want It When?

I hope to have a higher capacity drive (180k) on the system within a month or two and I have some improvements in the system planned, too. "When?" you ask? Soon. More details next month. Next month, I'll also have some comments on what some of the non-ham users have to say about our system.
